TEMPORARILY CLOSING THE WHOLE STRETCH OF GOV. FERRER AVENUE ON 19 AUGUST 2023 FROM 8:00 PM ONWARDS UNTIL THE CULMINATION OF THE ACTIVITIES THEREAT IN RELATION TO THE CELEBRATION OF ITS ANNUAL BARANGAY FIESTA AND THE COMMEMORATION OF THE 151ST BIRTH ANNIVERSARY OF GOV. LUIS OLIMPO FERRER, SR..

WHEREAS, annual Fiesta Celebration is a unique tradition of every Gentriseño and has become part of the main culture and religious events in the City;

WHEREAS, the Sangguniang Barangay of Governor Ferrer Avenue intends to hold its Fiesta Celebration on 19 August 2023 to commemorate the 151st Birth Anniversary of Gov. Luis Olimpo Ferrer, Sr. and recognize his selfless dedication to public service;

WHEREAS, the said Sangguniang Barangay requested to the Local Chief Executive the temporary closure of their road from 8:00 PM onwards until the culmination of the activities thereat in connection with the Fiesta Celebration;

WHEREAS, to promote a sense of togetherness and strengthen bonds among the Barangay Governor Ferrer Avenue residents, various activities including “Kainan sa Kalye Real” and raffle drawing will be carried out which require closure of the whole stretch of Governor Ferrer Avenue;

WHEREAS, Section 21 of the Local Government Code of 1991 (RA 7160) provides that a local government unit may, pursuant to an ordinance, temporarily close any local road;

WHEREAS, the Sanggunian deemed it necessary to temporarily close the whole stretch of Governor Ferrer Avenue to make way for the Fiesta Celebration and commemoration of the 151st Birth Anniversary of Gov. Luis Olimpo Ferrer, Sr.;

NOW THEREFORE, on motion of SP Member J-M Vergel M. Columna duly seconded by SP Member Isagani L. Culanding,

Be it enacted by the Sangguniang Panlungsod of General Trias, that:

Section 1. TITLE – This Ordinance shall be known as the “TEMPORARY CLOSURE OF GOV. FERRER AVENUE ON 19 AUGUST 2023 ORDINANCE”.



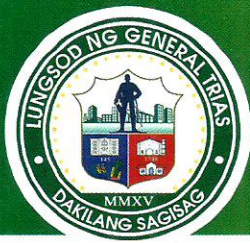

**TEMPORARY CLOSURE OF GOV. FERRER AVENUE ON 19 AUGUST 2023
ORDINANCE.**

Section 2. REGULATED ACTS – The whole stretch of Governor Ferrer Avenue shall be closed on 19 August 2023 from 8:00 PM onwards until the culmination of the activities thereat in relation to the celebration of its annual Barangay Fiesta and the commemoration of the 151st Birth Anniversary of Gov. Luis Olimpo Ferrer, Sr..


Coordination with the Offices of the City Mayor and City Traffic Management for their information shall be made regarding the traffic situations along the said area during the prescribed date.

Section 3. EFFECTIVITY CLAUSE – This Ordinance shall take effect upon its approval.
