MUNICIPAL ORDINANCE NO. 1-93

AN ORDINANCE REQUIRING ALL PREQUALIFICATION CONTRACTORS PARTICIPATING IN THE BIDDING OF PUBLIC WORKS PROJECTS TO PAY THE AMOUNT OF THREE HUNDRED FIFTY PESOS (P350.00) FOR BID DOCUMENTS AND FOR OTHER PURPOSES.


Section 2. The fee for bid documents as required herein is not refundable.

Section 4. This Ordinance shall take effect fifteen (15) days after its complete publication.


