GRANTING TAX CREDIT TO GENSTAR MANAGEMENT AND RESOURCES, INC. IN THE PAYMENT OF REAL PROPERTY TAX BY VIRTUE OF UNDERTAKING THE ASPHALTING AND OTHER DEVELOPMENT OF THE BY-PASS ROAD IN BARANGAY MANGGAHAN AND AUTHORIZING THE HON. MAYOR LUIS A. FERRER IV TO ENTER INTO THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE MUNICIPALITY FOR THE PURPOSE.

WHEREAS, pursuant to Section 192 of the Local Government Code of 1991, the Municipal Government may, through an ordinance duly approved, grant tax exemptions, incentives or relief under such terms and conditions as the municipal government may deem necessary;

WHEREAS, Genstar Management and Resources, Inc. will undertake the asphalting and development of the by-pass road in Bgy. Manggahan and therefore requested tax credit in the payment of real property tax on all of its properties;

WHEREAS, the aforecited asphalting of bypass road shall add more mileage to the development thrust of the present administration in supporting the economic progress in Bgy. Manggahan;

WEHREAS, a public hearing was conducted by this Body to enact an ordinance for the purpose;

WHEREAS, as provided in the amended Municipal Ordinance No. 4-93, Genstar Management and Resources, Inc. is qualified for the requested tax credit;

WHEREFORE, on motion of SB Member Carmelito B. Nocon duly seconded by all members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED to grant tax incentives to Genstar Management and Resources, Inc. to be designated as Municipal Ordinance No. 05-02, to be read as follows:

MUNICIPAL ORDINANCE NO. 05-02

GRANTING TAX INCENTIVES TO GENSTAR MANAGEMENT AND RESOURCES, INC. IN THE PAYMENT OF REAL PROPERTY TAX ON ALL OF ITS PROPERTIES.

Be it enacted by the Sangguniang Bayan of General Trias, Cavite, that:

Section I. - Genstar Management and Resources, Inc. shall be granted tax incentives in the payment of real property tax on all of its properties by virtue of the asphalting of the bypass road in Bgy. Manggahan.

Section II. - The tax incentives shall be administered by the Local Chief Executive through the Municipal Treasurer and Municipal Assessor upon the issuance of tax exemption certificate.

Section III. - This ordinance shall take effect during the next calendar year.
