RESOLUTION NO. 68-2001

WHEREAS, Sec. 129 Chapter I, Title I of the Local Government Code states that each local government shall have the power to create its own sources of revenues and to levy taxes, fees and charges;

WHEREAS, Sec. 130 (b) (2) Chapter I, Title I states that taxes, fees and charges and other impositions shall be levied and collected only for public purposes;

WHEREAS, heavy industrialization, the influx of factories to be exact is considered as contributory factor to the environmental pollution in the municipality;

WHEREAS, pollution situation in the municipality shall be balanced and monitored at all times;

WHEREAS, the municipal government shall institute preventive measures and programs to ensure the protection of air, water and natural resources which incur necessary expenses;

WHEREFORE, on motion of SB Member Carmelito B. Nocon duly seconded by SB Member Amelia P. Madrona, this Body

RESOLVED, as it is hereby resolved, to enact an ordinance to collect environmental protection fees as part of the local taxation code of the municipality of Gen. Trias, to be designated as Municipal Ordinance No. 05-2001, to read as follows:

MUNICIPAL ORDINANCE NO. 05-2001

AN ORDINANCE COLLECTING ENVIRONMENTAL PROTECTION FEES AS PART OF THE LOCAL TAXATION CODE OF THE MUNICIPALITY OF GENERAL TRIAS, CAVITE.

SECTION 3 - TIME OF PAYMENT. The fee imposed in this Article shall be paid to the Municipal Treasurer upon application/renewal of business permit.

SECTION 4 - SURCHARGE FOR LATE PAYMENT. Failure to pay the fee prescribed in this Article within the time required should subject the taxpayer to a surcharge of ten percent (10%) of the original amount fees due. Such surcharge to be paid at the same time and in the same manner as the fee due.

SECTION 5 - PENALTY. Any violation of the provisions of this Article shall be punished by a fine not less than One Thousand Pesos (P1,000.00) but not exceeding Five Thousand Pesos (P5,000.00) or imprisonment of not less than One (1) month but not exceeding Six (6) months, or both such fine and imprisonment, at the discretion of the Court.
