RESOLUTION NO. 31-2000

WHEREAS, the residents of Barangay Alingaro, General Trias, Cavite led by its incumbent Barangay Captain Angel Bawalan, had made representations to the Hon. Mayor Dencito P. Campaña for the acquisition of Barangay Road measuring about 8,580 square meters which they have been using for quite a number of years as one of the access roads to Barangay Alingaro;

WHEREAS, the Hon. Mayor Dencito P. Campaña had endorsed this matter to the Sangguniang Bayan of General Trias, Cavite which in turn directed the SB Legal Officer, Lawyer Rolando S. Torres to undertake the necessary initial steps for the acquisition of this Barangay Road;

WHEREAS, the SB Legal Officer had so far sent letters to Mr. Romeo "Jaime" King of 402-408 Tandang Sora Street, 1st Avenue, Grace Park, Caloocan City and Sps. Leoncio Siy and Erlinda Siy, et. al. of #11 8th Avenue, Cubao, Quezon City who appeared to be the registered owners of the lot where the above-mentioned Barangay Road is situated;

WHEREAS, despite the time given to above-mentioned persons, no response had been received from them thereby concluding that they are not agreeable to the offered price conveyed to them by the Municipality of General Trias, for the acquisition of the above-mentioned barangay road;

WHEREAS, the acquisition of said barangay road would surely redound to the benefit of the residents of Barangay Alingaro, this municipality;

NOW THEREFORE, under Sec. 447 of the Local Government Code, the Sangguniang Bayan has the power to enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Sec. 16 of the Local Government Code as well as the power of eminent domain as provided for under Sec. 19 of Local Government Code;

RESOLVED, as it is hereby resolved, to pass an ordinance authorizing and empowering the Hon. Municipal Mayor of General Trias, Cavite Dencito P. Campaña, to institute the necessary expropriation proceedings for the acquisition of the barangay road which will be redound to the benefit of the residents of General Trias, Cavite.

FURTHER RESOLVED, that the amount of P600,000.00 be initially appropriated for the filing of an action for expropriation proceedings before the regular courts as well as the costs of acquisition of the barangay road, subject of this resolution.

MUNICIPAL ORDINANCE NO. 06-2000

AN ORDINANCE EMPOWERING AND AUTHORIZING THE MUNICIPAL MAYOR OF GENERAL TRIAS, CAVITE TO INSTITUTE THE EXPROPRIATION PROCEEDINGS FOR THE ACQUISITION OF BARANGAY ROAD BEING USED BY THE RESIDENTS OF BARANGAY ALINGARO AS AN ACCESS ROAD AND PROVIDINGS FUNDS THEREOF.

Be it ordained and enacted by the Sangguniang Bayan of General Trias, Cavite, that:

Section 1. - The Hon. Mayor Dencito P. Campaña be given full and absolute authority to initiate expropriation proceedings of a portion of the property belonging to Romeo "Jaime" King and Sps. Leoncio and Erlinda Siy, et. al., located at Barangay Alingaro, General Trias, Cavite, pursuant to Section 19, Chapter I, Book I of the Republic Act No. 7160 otherwise known as the Local Government Code.

Section 2. - The amount of P600,000.00 be allocated for the purpose of acquiring portion of the property belonging to Romeo "Jaime" King and Sps. Leoncio and Erlinda Siy.

Section 3. - Copies of this ordinance be furnished the Sangguniang Panlalawigan for its information, guidance and approval pursuant to the pronouncements of the Supreme Court in the case of Municipality of Norzagaray, Province of Bulacan vs. Elbinians, et. al., 148 Scra, 83, 86.


