






WHEREAS, the prevailing fees and charges embodied in the Mun. Tax Code create deficit rather than earning to the local government unit;

OFFICE OF THE MUNICIPAL TREASURER

1. Banks and other financial institution 50% of 1% gross receipts of the preceding year derived from interest, commission and discounts from lending activities, income from financial leasing, dividends, rentals on property and profit from exchange on sale of property insurance premiums.

Amends from 50% of 1.5% gross receipts
 Ex. $2,000,000 \times 1\% = 20,000,000 \times 50\% = 10,000$
 $2,000,000 \times 1.5\% = 30,000,000 \times 50\% = 15,000$

2. Newly started business, the tax shall be at the rate of not exceeding one-tenth of one percent of its capital investment but in case shall it be less the minimum of 30.00 fixed above.

Ex. $1,000,000 \times 1\%/10 = 1,000$
