GRANTING FRANCHISE TO MR. OSCAR POBLETE FOR THE OPERATION OF MALABON GRANDE COCKPIT ARENA IN BARANGAY SAN JUAN II, THIS MUNICIPALITY.

Be it enacted by the Sangguniang Bayan that:

Section 1. The Local Government Unit grants franchise to Mr. Oscar Poblete for the operation of Malabon Grande Cockpit Arena in Barangay San Juan II, General Trias, Cavite.

Section 2. Any activity relative to the operation of Malabon Grande Cockpit Arena in Barangay San Juan II shall be in accordance with any existing regulatory acts and other necessary rules and regulations that the Municipal Mayor may impose for the effective implementation of this Ordinance.

Section 3. Effectivity. This Ordinance shall take effect upon its approval.
