AN ORDINANCE PROVIDING FOR THE CONDUCT OF KATARUNGANG PAMBARANGAY ANNUAL SEMINAR/WORKSHOP-TRAINING FOR ALL THE BARANGAY LUPONG TAGAPAMAYAPA IN THE MUNICIPALITY OF GENERAL TRIAS AND APPROPRIATING FUNDS FOR THE PURPOSE.

WHEREAS, the commitment and dedication of the Lupong Tagapamayapa in its tasks to promote and administer an effective system of justice at the barangay level is an integral element of a good, responsive, and accountable local governance;

WHEREAS, the Katarungang Pambarangay is a system of justice administered at the barangay level which aims to strengthen barangay governance by helping in the amicable settling of disputes thereby decreasing the number of cases filed in the Court;

WHEREAS, with the fast-evolving demand for access to justice, there is a need to utilize the above-mentioned barangay justice system more strategically and proactively as a way to promote peace at the grassroots level;

WHEREAS, Republic Act 7160, otherwise known as the 1991 Local Government Code, gives barangays the mandate to enforce peace and order and provide support for the effective enforcement of human rights and justice;

WHEREAS, the challenge facing local governments now is to maximize and harness the katarungang pambarangay as one of the most valuable mechanisms available in administering justice, advancing human rights protection and resolving and/or mediating conflict at the barangay level through non-adversarial means;

WHEREFORE, on motion of SB Member Florencio D. Ayos duly seconded by SB Member Kerby J. Salazar, SB Member Christopher N. Custodio, SB Member Lamberto M. Carampot, SB Member Richard R. Parin, SB Member Mario C. Amante, SB Member Jonas Glyn P. Labuguen and SB Member Gary A. Grepo,

Be it enacted by the Sangguniang Bayan, that:

Section 1. TITLE - "CONDUCT OF KATARUNGANG PAMBARANGAY ANNUAL SEMINAR/WORKSHOP-TRAINING ORDINANCE".

Section 2. SCOPE. - The Chairman and Members of the Lupong Tagapamayapa from each barangay in the municipality shall attend the Katarungang Pambarangay Annual Seminar/Workshop-Training to be conducted by Local Government Unit of General Trias in coordination with the Municipal Local Government Office (MLGO) to equip all concerned with legal understanding

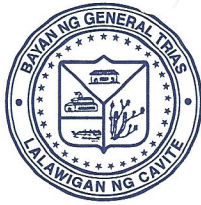

and skills for a more effective promotion and maintenance of peace and order in the barangay.

Section 3. FUNDING - Funding to support the conduct of the Katarungang Pambarangay Annual Seminar/Workshop-Training shall be taken from the Seminar/Training allocation of the Sangguniang Barangay and other support funds from the Office of the Municipal Mayor.

Section 4. CHECK UP MEASURES - After the conduct of the Katarungang Pambarangay Annual Seminar/Workshop-Training, each Lupong Tagapamayapa shall furnish the Mayor's Office, Liga ng mga Barangay (LNB), Municipal Interior and Local Government Office (MILGO), Municipal Trial Court (MTC), Sangguniang Bayan, etc. a quarterly report on the cases filed and the disputes being settled by the Lupong Tagapamayapa as to the effectivity of the program.

Section 5. EFFECTIVITY - This Ordinance shall take effect upon its approval.
